

Special Election Issue



The Virginia Catholic Conference is alerting all voters to several crucial issues that will be determined by the results of this year's Virginia election on November 4th. On that day, Virginians will select candidates for all 100 seats in the House of Delegates as well as for Governor, Lt. Governor and Attorney

General. While every year in Virginia is an election year, this November's elections are poised to have an outsized impact on our Commonwealth as our state legislators continue to consider three proposed constitutional amendments, including an extreme constitutional amendment establishing a "right" to abortion.

Three proposed Amendments to Virginia's Constitution would:



Create a radical "fundamental right" to abortion. (Opposed by VCC)



Remove Virginia's "union between one man and one woman" definition of marriage. (Opposed by VCC)

Restore voting rights to all who have completed prison sentences.

These three proposals were initially approved by the General Assembly earlier this year. If they pass the legislature again in 2026 – and are then approved by Virginia voters on a ballot – they would become law. The proposed amendment on abortion would enshrine virtually unlimited abortion at any stage of pregnancy as a "fundamental right" in Virginia's constitution. In addition to the paramount problem of not recognizing the child's life, the amendment:



Does not include any age restriction



Does not include any safety standards



Jeopardizes Virginia's parental consent law



Jeopardizes Virginia's conscience protections for healthcare providers, *including pregnancy centers*



Expands Virginia's already permissive abortion laws.

To end a life is not a right and does not belong in the constitution.

Bishop Knestout, in a letter last month stated, "As the *Catechism* reminds us, 'It is necessary that all participate, each according to his position and role, in promoting the common good.... As far as possible, citizens should take an active part in *public life*' (nos. 1913-1915). To promote the common good, we must form our consciences and vote, recognizing that:

- Many issues are important.
- Not all issues have equal moral weight.
- Protecting life is paramount.

Above all else, addressing the tragedy of abortion is the 'pre-eminent priority because it directly attacks our most vulnerable and voiceless brothers and sisters and destroys more than a million lives per year in our country alone'
